TERMS AND CONDITIONS OF SALE:

All orders are subject to the following Terms and Conditions: Any changes or deviations to the description of work as described on the corresponding written Packaging Validators quotation and/or any related changes to the supplied materials or specifications may constitute a change in price. Customer is solely responsible for the performance and quality of supplied materials and that such supplied materials and all specified materials meet any and all of its requirements. Customer shall be solely responsible for assuring that the materials and products supplied by Packaging Validators have been tested under actual operational and end-use conditions and are suitably fit for Customer's end-use purposes. Customer is solely responsible for any freight carrier transit damage. Packaging Validators' liability is limited solely to the replacement, repair, or correction of damaged product. In no event shall Packaging Validators be liable for incidental, indirect, compensatory, punitive, consequential, special, or other damages, including, but not limited to, loss of profits and lead time delays.

ORDER CANCELLATION or QUANTITY REDUCTION: Orders cancelled after 72 hours of Purchase Order issuance are subject to a fee due Net 15 days from date of order cancellation. This fee shall equal the cost of raw materials procured to produce your order plus \$100 of administrative costs. If the quantity quoted is reduced or if specifications change, Packaging Validators LLC reserves the right to revise its written quotation.

PRODUCT SHIPPING DAMAGE CLAIMS OR PRODUCT QUANTITY SHORTAGES: Customer is responsible for notifying the freight carrier in writing at time of inbound receipt of any and all shipping damages by describing such damage on the associated bill of lading and taking accompanying photographs to visually demonstrate such damage prior to the freight carrier's departure from customer's receiving facility. Customer is also responsible for verifying quantity counts upon inbound receipt to assure a match to the packing slip and notifying freight carrier in writing at time of inbound receipt of any and all quantity shortages on the associated bill of lading and taking accompanying photographs to visually demonstrate such shortage prior to the freight carrier's departure from the customer's receiving facility. In either instance, an email with photos of all damages or shortages must be sent to careteam@validatorsllc.com within 1 hour of notifying the freight carrier as such. Under no circumstances shall Packaging Validators be responsible for correction or rectification of shipping damages or shortages if the freight carrier was not properly notified or without supporting photos time-dated prior to the departure of the freight carrier from customer's receiving facility. If the freight carrier does not admit or agree of such damage or shortage, then the customer shall refuse acceptance of the delivery.
